

## UrbanBCN Worldwide Appears on the Annual Inc. 5000 List of America's Fastest-Growing Private Companies

**Ranking No. 2459 with three-year revenue growth of 167.93 percent, this is their second year in a row of recognition for impressive expansion numbers.**

**NEW YORK || August 12, 2020** – *Inc.* magazine today revealed that UrbanBCN Worldwide is No. 2459 on this year's Inc. 5000 list, the annual ranking of the nation's fastest-growing private companies. The list represents the most successful companies within the American independent small business segment, based on aggregate growth numbers from the previous three years.

Based in San Francisco, UrbanBCN Worldwide has provided luxury executive transportation services to the Bay Area and beyond for over 40 years, currently operating in more than 700 cities around the world. As the result of an acquisition in 2016, their fleet more than tripled overnight and paved the way for the exponential growth that would follow. Most recently, the launch of their private aviation network, UrbanAir, has enabled them to bring their innovative and dynamic performance to every niche of the private travel industry.

"It feels great to look at the numbers and know we generated that growth with just a small, fully remote team, obsessive standards of service, and a lot of heart," said CEO Dave Uziel. "We hustle every day, and I couldn't be happier with where we are, and where we're going."

Not only have the companies on the 2020 Inc. 5000 been competitive within their markets, but the list as a whole shows increased growth compared with prior lists. The 2020 Inc. 5000 achieved a three-year average growth of over 500 percent, and a median rate of 165 percent. The Inc. 5000's aggregate revenue was \$209 billion in 2019, accounting for over 1 million jobs over the past three years.

### Methodology

To qualify for the Inc. 5000, companies must have been founded and generating revenue by March 31, 2016. They had to be US-based, privately held, for profit, and independent as of December 31, 2019. \*A number of companies on the list have gone public or been acquired since then. The minimum revenue required for 2016 was \$100,000; the minimum for 2019 was \$2 million.
